## RELEASE OF LIABILITY AND PHOTO RELEASE

I understand and expressly agree that this release, waiver and agreement is intended to be as broad and inclusive as permitted by the laws of the State of Wyoming and that I have carefully read this release and know the content of the release, and sign this release as an act of my own free will, and that the terms of this release are contractual in nature.

I am aware that there are inherent risks and hazards involved in activities with and around dogs and other pet(s) and animals, and I am voluntarily participating in these activities with knowledge of these potential dangers. I am not relying on New Tricks Pet or its staff, volunteers, management or owners, to prevent such occurrences. I hereby waive any and all claims or action that I, or my guardians, representatives, heirs, or assigns may have against New Tricks Pet and agree to release New Tricks Pet from any and all liability for personal injury to myself, my dog(s), other pet(s), children in my charge, or harm to property caused directly or indirectly by acts that might occur while New Tricks Pet is caring for my animals and property. I further agree to indemnify, defend and hold New Tricks Pet harmless for damage, loss, liability or expenses, including legal costs and attorney's fees which result from any damage caused by myself, children in my charge, or dog(s), or other pet(s) that I own or handle.

I authorize New Tricks Pet to photograph and/or video me and/or my pet and to use these images as determined by New Tricks Pet, and hereby waive my claim to any compensation for such use.
